The Federation's work continues to draw national attention. The Governmental Research Association honored The Civic Federation for our successful work to eliminate unnecessary government and our groundbreaking property tax research. *Chicago Magazine* also recently ranked the Federation's website as one of the best in Chicago, calling www.civicfed.org "an invaluable and free online resource." From the editorial pages of the *Wall Street Journal* to the *New York Times* and *Washington Post*, the Civic Federation's efforts to reform government are making headlines nationwide.

With your support, The Civic Federation will continue to have a significant impact on the State of Illinois and local governments. If you are not yet a member of The Civic Federation, I encourage you to consider joining our efforts. Our success in improving government efficiency and fiscal responsibility depends on the involvement of business and civic leaders like all of you here in this room.

SALUTATION SPEAKER

JUDGE VIRGINIA M. KENDALL



Judge Kendall was appointed to the federal bench in January 2006. Prior to her appointment she worked at the United States Attorney's Office here in Chicago where she served as a Deputy Chief in the Criminal Division, as Coordinator of *Project Safe Neighborhoods*, and as the Child Exploitation Coordinator. Prior to working with the United States Attorney's Office, Judge Kendall clerked for Hon. George Marovich in the Northern District of Illinois.

For the past fourteen years, Judge Kendall has been an adjunct professor of trial practice and federal criminal prosecution at Loyola University School of Law and an adjunct professor at Northwestern University for the past two years. She also has published law journal articles in the *Northwestern University Law Review* regarding child molestation statutes and sentencing. As a trial attorney, Judge Kendall prosecuted a variety of federal crimes including violent crimes, white collar fraud, insurance fraud, police corruption, public corruption, and racketeering cases. She has lectured extensively in the areas of internet and computer investigations and trained federal and local law enforcement agents. She has also worked to train outside private and public sector organizations including the Chicago Public Schools, the Chicago Police Department, and the National Center for Exploited and Missing Children. She has also participated in numerous academic symposiums and panels and served on the *Attorney General's National Advisory Committee* that reviewed all nationwide child exploitation investigations.

For three years, she also co-coordinated the federal program *Project Safe Neighborhoods*, which is designed to reduce gun violence within the city. As coordinator, she worked closely with local police departments, ATF, the Illinois Department of Corrections, and grass roots organizations to eradicate the use of weapons that result in violence and drug trafficking. She lectured extensively on the goals of the program and conducted forums for convicted felons who were being released into the community regarding the need to lay down weapons and seek alternative choices in life.

Aside from her professional roles, Judge Kendall has participated in a number of service projects that support high school students, including moderating service trips to Peru, establishing trial training programs, and developing awareness and support programs to curb gun violence. She was awarded the Chicago Crime Commission's Star of Distinction Award for her work in law enforcement, the Loyola University Bellarmine Award for her distinguished legal and service contributions to the community, and will receive the Rape Victim Advocates' Visionary Award this month for her work with victims of child exploitation. Judge Kendall received her undergraduate and masters degrees from Northwestern University and her law degree from Loyola University School of Law.

THE ADDAMS-PALMER AWARD

Presented for the first time in 1995, this award honors Jane Addams and Bertha Honoré Palmer, two outstanding Chicagoans who served as founders of The Civic Federation. In their memory, the Addams-Palmer Award is given each year in recognition of outstanding involvement by an individual or institution.

Nobel Peace Prize winner Jane Addams, who founded Hull House on Chicago's Near West Side, is remembered for her passionate dedication to social reform, both in Chicago and throughout the world. Miss Addams embodied the civic pride, altruism, optimism, energy, and determination that characterized an entire generation of Chicago reformers. Through her heartfelt commitment to the immigrants served by Hull House, Miss Addams grew into a major force for change in Chicago politics. As a founder of The Civic Federation, she battled corruption in City Hall, joining forces with business leaders, social activists, and other concerned citizens with the goal of making Chicago "the best governed, the healthiest, and the cleanest city in the country."

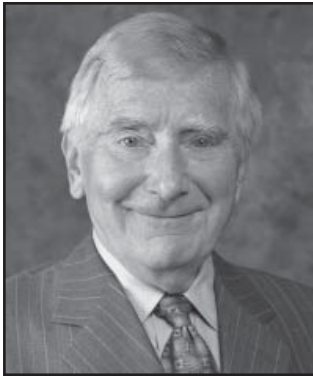
The wife of Chicago's richest man, Bertha Honoré Palmer was the acknowledged leader of Chicago society, known for her superb taste, her generous philanthropy, and her keen sense of social justice. She gained national prominence as the president of the Board of Lady Managers of the Columbian Exposition of 1892. Although the ladies' board was originally intended to be largely honorary, the ladies – under Mrs. Palmer's guidance – succeeded in creating one of the gems of the Exposition, the Women's Building. A friend of Jane Addams, Mrs. Palmer gave both time and money to support Hull House and joined with Miss Addams in launching The Civic Federation. After her husband's death in 1902, Mrs. Palmer took over active management of his \$8 million estate; she more than doubled the estate's value over the next decade. On her death, she left the Art Institute of Chicago more than 50 paintings by Cassatt, Monet, Renoir, Manet, Degas, and many others; those works now make up the heart of the Art Institute's Impressionist collection.

Few corporations touch as many Illinois residents as BlueCross BlueShield. Established in 1936 as Hospital Service Corporation, and now with over seven million members, BlueCross BlueShield of Illinois is the state's largest health insurance provider. One of the nation's first health insurance providers, BlueCross continues to innovate via its on-going commitment to the health and wellness of its members, employees, and communities throughout the state.

BlueCross has a strong tradition of philanthropy, as evidenced by its numerous contributions to communities in Chicago and throughout Illinois. In 2007 alone BlueCross provided grants and sponsorships to over 300 not-for-profit organizations across Illinois, totaling approximately \$3.5 million. The majority of the recipients were community-based organizations that provide greater access to health care for Illinois' most vulnerable citizens, including Community Health, Mercy Home for Boys and Girls, and the Night Ministry. BlueCross also is a major supporter of the United Way of Metropolitan Chicago and last year was one of the organization's leading contributors.

Recently BlueCross has focused its efforts on childhood health, especially working to combat childhood obesity. To this end, BlueCross has partnered with the University of Illinois at Chicago to provide in-school curriculum that promotes healthy lifestyle habits and behaviors among participating elementary school students. In Chicago BlueCross sponsors the Mayor's Office of Special Events' Bike Chicago program, which motivates Chicagoans to become more physically active through bike riding, and the Holiday Sports Festival, which gives Chicago children a safe place to play during their winter break from school. To ensure that efforts to promote childhood health are effective, BlueCross joined the Corporate Advisory Committee of the Consortium to Lower Obesity in Chicago's Children (CLOCC). BlueCross supports efforts by CLOCC, the Illinois Department of Public Health, and a host of other organizations to develop a statewide database to monitor children's health and measure the effects of programs that fight childhood obesity. BlueCross is also working to address youth violence by funding and supporting organizations like After School Matters and Broader Urban Involvement and Leadership Development (BUILD).

Since 1990 BlueCross has operated its own CareVan mobile clinic program. Specially equipped CareVans, along with public health nurses, travel to underserved communities throughout the state to administer immunizations and conduct health screenings in an effort to enhance the health of Illinois residents.

The 2008 Addams-Palmer Award will be accepted on behalf of BlueCross BlueShield by Raymond F. McCaskey, CEO of Health Care Service Corporation (HCSC), which operates the BlueCross BlueShield Plans in Illinois, New Mexico, Oklahoma, and Texas. HCSC is the fourth largest health insurance company in the United States. A strong commitment to people, quality, and service is Mr. McCaskey's hallmark, as evidenced by the company and Mr. McCaskey's numerous awards for promoting employee diversity and by his outspoken advocacy for making health insurance more accessible and affordable for all Americans. Mr. McCaskey is a proud graduate of Wartburg College and DePaul University and leads the BlueCross BlueShield employee efforts that support the United Way of Metropolitan Chicago, American Heart Association, American Cancer Society, Chicago Lighthouse for the Blind, and many other critical Chicago civic endeavors. Last year, under Mr. McCaskey's leadership, BlueCross' more than 7,000 Illinois-based employees donated thousands of hours of their personal time and materials to help the state's communities.

THE LYMAN J. GAGE AWARD

In keeping with the civic commitment and vision of its first president, The Civic Federation annually presents the Lyman J. Gage Award for Outstanding Civic Contribution to an individual who has consistently demonstrated dedication to civic concerns in the Chicago area.

Lyman Judson Gage (1836-1927) was born in upstate New York. As a young man, he moved to Chicago and began working for The First National Bank, where he rose from cashier to bank president.

In 1889 Chicago's City Council launched a bid to host a World's Fair commemorating the 400th anniversary of Christopher Columbus' voyage to the New World. Gage was one of 100 prominent citizens appointed to a committee to promote Chicago's bid. At the time, public opinion was mixed on the wisdom of investing in such an extravagant undertaking. However, Gage saw the proposed Fair as an opportunity to showcase Chicago as a world-class city and led a \$10 million fundraising drive to build the World's Columbian Exposition. Although cynics predicted disaster, the 1893 Exposition was a great critical and financial success. More than 27 million people visited the Fair during its six-month run, and it provided an important source of jobs during a time of national economic depression.

In the wake of the Fair, Chicago confronted serious economic challenges compounded by widespread corruption in city government. In response Gage helped to organize a series of conferences to address the problems of rampant poverty, gambling, and prostitution. At one of the conferences, the featured speaker was journalist William T. Stead, author of the muckraking book *If Christ Came to Chicago*. Stead's speech so electrified the audience that they resolved to join together to address Chicago's urgent need for reform. That group became The Civic Federation, which was formally incorporated in February 1894. Gage was elected president of The Civic Federation at its incorporation and was joined by Jane Addams and Bertha Palmer as the organization's first officers.

In 1897 Gage joined the cabinet of President William McKinley as Secretary of the Treasury. He was reappointed by President Theodore Roosevelt but left in 1902 to become the president of The United States Trust Company in New York. Gage retired in 1906 to San Diego, where he died in 1927.

LYMAN J. GAGE AWARD RECIPIENT

JOHN W. ROWE



John W. Rowe is the chairman and chief executive officer of Exelon Corporation, a utility holding company headquartered in Chicago. Exelon has the largest market capitalization in the electric utility industry. Its retail affiliates serve 5.4 million customers in Illinois and Pennsylvania, and its generation affiliate operates the largest fleet of nuclear power plants in the nation.

Rowe is the senior chief executive in the utility industry, having served in such positions since 1984. Rowe has led Exelon since its formation in 2000 through the merger of PECO Energy and the parent of Commonwealth Edison. Rowe previously held chief executive officer positions at the New England Electric System and Central Maine Power Company, served as general counsel of Consolidated Rail Corporation, and was a partner in the law firm of Isham, Lincoln and Beale. Rowe serves as chairman of the Nuclear Energy Institute, is a past chairman of the Edison Electric Institute, and is a co-chairman of the National Commission on Energy Policy, an industry and environmental organization dealing with climate change. He is a member of the boards of directors of Sunoco and the Northern Trust Company. In January 2008, *Institutional Investor* named Rowe the best electric utilities CEO in America.

Rowe is committed to a wide variety of civic and charitable activities, with a focus on education, science, history, and diversity. He serves as chairman of Chicago's Commercial Club, the Illinois Institute of Technology, and the Chicago History Museum, and is a member of the boards of the Field Museum, the Wisconsin Alumni Research Foundation, and the Morgridge Institute for Research. Along with his wife, Jeanne, and son, William, he has established the Rowe Family Charitable Trust, founded the Rowe-Clark Math and Science Academy in Chicago's West Humboldt Park neighborhood, served as patron of the John Paul II parochial school on Chicago's southwest side, founded the Rowe Professorship of Byzantine History at the University of Wisconsin, and the Rowe Professorship of Architecture at the Illinois Institute of Technology.

Rowe has been widely recognized for his civic and professional leadership. Recent awards include the Illinois Holocaust Museum's Humanitarian award (2008), University of Arizona's Executive of the Year Award (2007), the Union League of Philadelphia's Founder's Award for Business Leadership (2005), the American Jewish Committee's Civic Leadership Award (2004), El Valor's Corporate Visionary Award (2003), the Spanish Coalition for Jobs' Corporate Leadership Award (2002), the City Club of Chicago's Citizen of the Year Award (2002), and the Anti-Defamation League's World of Difference Award (2000).

Rowe holds undergraduate and law degrees from the University of Wisconsin, where he was elected to Phi Beta Kappa and the Order of the Coif. He has also received that university's Distinguished Alumni Award. Rowe holds honorary doctorates from DePaul University, Illinois Institute of Technology, Drexel University, University of Massachusetts-Dartmouth, Bryant College, and Thomas College.

Rowe and his wife, Jeanne, reside in Chicago, as does their son, William, an associate with the law firm of Skadden, Arps, Slate, Meagher and Flom.
